CLIENT UNDERSTANDS AND AGREES THAT ZERLOTTI EQUINE WILL NOT ACCEPT HORSE AND WILL NOT RENDER ANY SERVICES UNLESS AND UNTIL THIS AGREEMENT (INCLUDING THE VACCINATION RECORD) IS EXECUTED AND DELIVERED BY CLIENT TO ZERLOTTI EQUINE, ALONG WITH A COPY OF HORSE'S REGISTRATION PAPERS AND A CURRENT (WITHIN THE LAST 12 MONTHS) NEGATIVE EQUINE INFECTIOUS ANEMIA (COGGINS) TEST.

Description of services:

- Embryo Transfer Enrollment Fee, on site, per cycle.** Client shall pay Zerlotti Equine a non-refundable Enrollment Fee according to the fee schedule above *prior* to commencement of any Embryo Transfer Services. The Enrollment Fee is consideration for securing embryo transfer services to be provided by Zerlotti Equine and includes palpation, ultrasounds, insemination with fresh or cooled semen, medication administration to induce ovulation and short cycle Donor Mare, and embryo flush/collection for one heat cycle. If the donor mare is not inseminated, a credit for the value of Artificial Insemination will be applied to the donor mare's charges for that cycle (See Rate Schedule).
- Embryo Transfer Enrollment Fee for shipped embryos** is consideration for securing embryo transfer services to be provided by Zerlotti Equine and the availability of a synchronized recipient mare for a Donor Mare who is managed off-site. If the donor mare is not inseminated or Zerlotti Equine does not receive an embryo a credit of \$250 will be applied to the charges for that cycle.
- Embryo Flush Only** applies when Donor Mare is bred off-site and brought on-site to Zerlotti Equine for flush of and possible collection of an embryo. The fee includes embryo flush/collection and prostaglandin administration for one embryo.
- Embryo Transfer Fee** includes non-surgical transfer of embryo to recipient mare, ultrasound pregnancy examinations and progesterone administration through 30 days of gestation. The Embryo Transfer Fee is in addition to the Enrollment Fee or Flush Only Fee.
- Embryo Transfer 30-day Pregnancy Fee** is due and payable when the recipient mare is confirmed 30 days in foal. If the recipient mare loses the pregnancy after 30 days of gestation AND is still located on our premises, the Donor Mare/Embryo owner will receive a credit against their account for the 30-day Pregnancy Fee. This credit will be applied to services for the current breeding season or may be carried over to the next breeding season. Any credit on the Client's account must be used before the end of the next breeding season or the credit will expire and the Client will forfeit any existing credit on the account. Additionally, client will NOT receive a credit if Zerlotti Equine is not named as additional insured on any embryo/in utero foal insurance (See Section 11, "Insurance"). **Credits are not transferable to another client but may be transferred to another mare with prior notice and execution of a new service agreement.**
- THE RECIPIENT MARE IS THE PROPERTY OF ZERLOTTI EQUINE.** Client shall pay Zerlotti Equine a refundable deposit of \$1,000.00 (hereinafter "Recipient Mare Deposit"), for each recipient mare carrying an in uterus embryo/foal resulting from Embryo Transfer Services provided pursuant to this Agreement, prior to the recipient mare's departure from Zerlotti Equine's facilities. Each recipient mare is required to be returned to Zerlotti Equine's facilities at Client's expense within 6 months of foaling or by December 31st of the year foaled, whichever is later, in order to receive a refund of the Recipient Mare Deposit. Zerlotti Equine is entitled to retain each Recipient Mare Deposit for each recipient mare that is not returned to Zerlotti Equine within the timeframe described above as liquidated damages, and may seek all other remedies at law and equity to which it is entitled. In lieu of the Recipient Mare Deposit, Client may purchase the Recipient Mare for \$1,000.00 but will not be entitled to a refund the following year. Purchase of the Recipient Mare does not obligate Zerlotti Equine to re-purchase the mare.
- Foaling Fee, uncomplicated delivery, per foal.** The Foaling service includes supplies and materials necessary to perform an uncomplicated foaling. This service does not include medications or veterinary services provided in case of an emergency or complicated foaling.

Zerlotti Equine, at its sole discretion, will determine if the horse needs another form of boarding for any reason, including, but not limited to, injury, disease, or behavior problems, and the client will be charged accordingly. Zerlotti Equine shall at all times maintain Horse in accordance with generally accepted standards in the horse industry. **Boarding fees are billed in advance and are due and payable by the tenth (10th) of each month or within ten (10) days of invoice date.**

6. **MISCELLANEOUS SERVICES, FEES AND EXPENSES.** Client shall pay all miscellaneous fees and expenses as set forth in this Agreement and as may be increased or modified hereafter by Zerlotti Equine together with all amounts necessary to reimburse Zerlotti Equine for services provided and all expenses incurred on behalf of Client. Client shall also pay or reimburse Zerlotti Equine promptly for all taxes, however defined or denominated except income taxes, related to this transaction or this Agreement, and for any interest and penalties imposed in connection with such taxes. Such amounts described in this Section shall be referred to in this Agreement as "Miscellaneous Fees and Expenses."
7. **BILLING TERMS.** Client shall pay all fees and expenses incurred under this Agreement upon receipt of the statement(s) for such fees and expenses. Payment shall be deemed late if not paid within ten (10) days from the date such statement is deposited in the United States mail, emailed or personally delivered. IF CLIENT FAILS TO OBJECT IN WRITING TO ANY ITEM CHARGED IN A STATEMENT WITHIN TEN (10) DAYS FROM THE DATE SUCH STATEMENT IS DEPOSITED IN THE UNITED STATES MAIL, E-MAILED OR PERSONALLY DELIVERED, THEN IT SHALL BE CONCLUSIVELY AGREED BY CLIENT THAT SUCH AMOUNT IS FAIR AND CORRECT AND IS OWED TO ZERLOTTI EQUINE AND THAT CLIENT WAIVES ANY CHALLENGE TO THE FEES AND EXPENSES CHARGED. If Client fails to make timely payment of any amount due under this Agreement, Client shall be in breach of this Agreement. A VALID CREDIT CARD IS REQUIRED TO BE KEPT ON FILE AND WILL BE USED TO SETTLE OWNER'S ACCOUNT IF PAYMENT IN ANOTHER FORM IS NOT RECEIVED WITHIN TEN (10) DAYS OF STATEMENT DATE. SERVICES WILL NOT BEGIN UNTIL THE CREDIT CARD INFORMATION IS RECEIVED. Client also agrees that time is of the essence in payment of all amounts due under this Agreement and that it would be impractical to fix the exact amounts of Zerlotti Equine's damages if Client fails to pay promptly. Therefore, if any such amounts are not paid in full on or within thirty (30) days of the date shown on the Statement, Client agrees that Zerlotti Equine shall then be entitled to charge as liquidated damages on the then unpaid balance interest at the rate of 1.5% per month from the date of such statement until paid or the highest rate permitted by law, whichever is greater. All payments hereunder shall be made in lawful money of the United States at the office of Zerlotti Equine at the address set forth. Visa, MasterCard and Discover credit cards are accepted for payment. A fee of \$40.00 will be charged for returned checks. A 2% discount is available to the amount owed if payment is received via bank wire transfer to a Zerlotti Equine account by the 10th of the month or within 10 days of the invoice/statement date.
8. **SECURITY INTEREST AND LIEN.** CLIENT SPECIFICALLY AGREES THAT NOTWITHSTANDING ANY OTHER PROVISION OF THIS AGREEMENT, ALL AMOUNTS OWED UNDER THIS AGREEMENT SHALL BE DUE AND PAYABLE BEFORE HORSE WILL BE RELEASED BY ZERLOTTI EQUINE. IN ADDITION TO THE FOREGOING, CLIENT HEREBY GRANTS ZERLOTTI EQUINE A SECURITY INTEREST AND LIEN IN HORSE AND ANY IN UTERUS EMBRYO(S)/FOAL(S) RESULTING FROM ANY SERVICES PROVIDED BY ZERLOTTI EQUINE PURSUANT TO THIS AGREEMENT AS SECURITY FOR ALL PAYMENTS NOW OR HEREAFTER OWING UNDER THIS AGREEMENT AND PERFORMANCE OF ALL OBLIGATIONS OF CLIENTS UNDER THIS AGREEMENT. IF CLIENT IS NOT THE LEGAL OWNER OF HORSE, CLIENT SPECIFICALLY REPRESENTS AND WARRANTS THAT THE PERSON SIGNING THIS AGREEMENT IS A DULY AUTHORIZED ATTORNEY-IN-FACT WITH SUFFICIENT AUTHORITY TO EXECUTE THIS AGREEMENT AND GRANT THE SECURING INTEREST AND LIEN GRANTED HEREBY FOR THE OWNER OF HORSE. ZERLOTTI EQUINE MAY, AT ANY TIME UNTIL ALL AMOUNTS DUE HEREUNDER ARE FULLY PAID AND ALL OBLIGATIONS REQUIRED OF CLIENT THEREUNDER ARE FULLY PERFORMED, FILE A PHOTOCOPY OF THIS AGREEMENT IN THE COUNTY AND STATE OF CLIENT'S RESIDENCE OR BUSINESS OR WHERE SUCH HORSE IS LOCATED, AND WHEN SO FILED THIS AGREEMENT SHALL BE EFFECTIVE AS A FINANCING STATEMENT AS WELL AS A SECURITY AGREEMENT. CLIENT AGREES TO EXECUTE, FILE AND RECORD SUCH OTHER STATEMENT, NOTICES AND AGREEMENTS, TAKE SUCH ACTIONS AND OBTAIN SUCH DOCUMENTS AS ZERLOTTI EQUINE SHALL DEEM NECESSARY TO FURTHER OBTAIN, PERFECT AND RETAIN SUCH SECURITY INTEREST AND LIEN. CLIENT APPOINTS MARIO ZERLOTTI AS ITS ATTORNEY-IN-FACT TO EXECUTE AND FILE UCC-1 FORMS AND OTHER DOCUMENTS TO RECORD, PERFECT, AND PROTECT SUCH SECURITY INTEREST AND LIEN GRANTED HEREIN. IF CLIENT FAILS TO PERFORM FULLY AND TIMELY ANY OBLIGATION UNDER THIS AGREEMENT, ZERLOTTI EQUINE, AT ITS OPTION, MAY DECLARE A DEFAULT AND EXERCISE ALL RIGHTS IN HORSE ALLOWED BY THIS AGREEMENT AND TEXAS LAW, INCLUDING THE TEXAS UNIFORM COMMERCIAL CODE.
9. **HEALTH REQUIREMENT AND VACCINATIONS.**
- Client warrants that Horse is free from all contagious and infectious diseases upon delivery to Zerlotti Equine.
 - Prior to arrival of Horse at Zerlotti Equine's facilities, Client shall have Horse vaccinated and tested for and shall provide a record of the Horse's vaccination for Strangles, Equine Influenza, Tetanus Toxoid, Encephalomyelitis, Rhinopneumonitis, West Nile Virus, and Equine Viral Arteritis within the last ninety (90) days, but not less than twenty-one (21) days prior to arrival of Horse at Zerlotti Equine's facilities and must provide a current negative Equine Infectious Anemia (Coggins) Test. See Exhibit "A".
 - If Horse arrives at Zerlotti Equine's facilities without current vaccinations and/or Coggins Test, Zerlotti Equine will place Horse in quarantine at the rate of \$25.00 per day until Client, at its sole expense, obtains vaccinations and/or Coggins Test for Horse. If Horse tests positive for EIA (Coggins test) then Horse will not be accepted by Zerlotti Equine and Horse will remain in quarantine until owner provides for re-location transportation.
 - If at any time while Horse is at Zerlotti Equine's facilities, it is determined by Zerlotti Equine, in its sole discretion, that Horse has a contagious or infectious disease or for any other medical reason should be removed from Zerlotti Equine's facilities, Zerlotti Equine shall give Client notice of such condition and shall have the right to have Horse removed from Zerlotti Equine's facilities immediately, at Client's sole expense.
 - Client hereby authorizes Zerlotti Equine to provide or arrange for, at Client's sole expense, all veterinarian services or treatment for Horse which Zerlotti Equine reasonably believes to be necessary.
10. **TRANSPORTATION AND RELEASE OF HORSE.**
- Client shall be solely responsible for arranging and paying the costs for transporting Horse and, in the case of embryo transfer, the Recipient Mare in connection with this Agreement.
 - Account must be paid in full prior to release of Horse from Zerlotti Equine's facilities. Client specifically agrees that Zerlotti Equine may retain possession of Horse until Client has paid all amounts owed to Zerlotti Equine and performed fully all obligations required of Client under this Agreement.
 - Client shall provide Zerlotti Equine with **at least one week advance notice (excluding weekends)** of intent to pick-up Horse. Client shall provide Zerlotti Equine with written authorization to release Horse to any third party transporter and Zerlotti Equine shall have no obligation to release Horse without such written authorization. Transportation arrangements must be made between the hours of 8 a.m. and 5 p.m. CST Monday through Friday. Upon commencement of the loading of Horse by a third party transporter, Client assumes full responsibility and liability for the health, soundness, breeding condition, transportation and care of Horse.

- d) Client hereby authorizes Zerlotti Equine during the time Horse is boarded at Zerlotti Equine's facilities pursuant to this Agreement to transport, or to select a third party to transport, Horse to a veterinary medical facility if Zerlotti Equine determines, in its sole discretion, that such off-site veterinary services are necessary. Client agrees to pay for any such transportation.
- e) Zerlotti Equine shall have the right to require that Horse receive, at Client's sole expense, a veterinarian's certificate of health prior to Horse's release from Zerlotti Equine.
- f) Client will be charged an additional fee if Horse arrives or departs before/after normal barn hours of 7 a.m. to 7 p.m. CST. (See Service Rate Schedule)

11. INSURANCE.

- a) **Horse:** Client is responsible for obtaining any insurance Client desires for Horse. If Client obtains insurance for Horse, Client shall provide Zerlotti Equine a certificate of insurance evidencing same. If Client does not obtain insurance, Client acknowledges that he/she/it is self-insured and assumes full responsibility of any loss incurred with respect to Horse.
- b) **Embryo/In Utero Foal:** Client is responsible for any insurance desired on the recipient mare and/or in utero foal. Client must initiate application with the insurance company of their choice and provide Zerlotti Equine with any necessary forms in order to arrange for veterinarian certification of in utero/embryo. Zerlotti Equine Reproduction, Ltd. must be named as additional insured on the policy up to the value of the embryo transfer fees and the cost of the recipient mare. In the event of a loss, Client will not receive the credit referenced in the Embryo Transfer Service Agreement, "Description of Services" section, paragraph #5, if the embryo/in utero foal is insured and Zerlotti Equine is not named as additional insured. If Client obtains insurance, Client shall provide Zerlotti Equine Reproduction, Ltd. a certificate of insurance evidencing same and naming Zerlotti Equine Reproduction, Ltd. as additional insured. If Client does not obtain insurance, Client acknowledges that he/she/it is self-insured and assumes full responsibility of any loss incurred with respect to Recipient Mare and/or in utero foal.

12. SALES COMMISSION AND ZERLOTTI EQUINE'S RIGHT TO SERVE AS JOINT AGENT. If (a) Client Horse is placed in Zerlotti Equine's Breeding Program, and Horse is sold while in said program; or (b) Horse is sold as a result of activities by Zerlotti Equine or any of its employees; or (c) Horse is otherwise sold to a person or entity for which Zerlotti Equine or any of its employees is the procuring cause, then Client shall pay Zerlotti Equine promptly at the time of such sale an amount equal to fifteen percent (15%) of the total purchase price or value of the consideration to be received by Client. Client agrees that Zerlotti Equine and any of its employees may serve as both an agent for Client and as an agent for the purchaser of Horse, and may receive compensation from the purchaser for Zerlotti Equine services in addition to the commission from Client. Client hereby knowingly and freely waives any conflict for its acts on behalf of the Client with respect to such dual agency.

13. DISCLAIMER OF AND LIMITATIONS TO ZERLOTTI EQUINE REPRODUCTION LTD'S LIABILITY. EXCEPT IN THE EVENT OF INTENTIONAL MISCONDUCT, ZERLOTTI EQUINE REPRODUCTION, LTD., ITS OWNERS, PARTNERS, PRINCIPALS, AGENTS, EMPLOYEES, SERVANTS, VETERINARIANS AND FARRIERS, OR ANY OF THEM, HEREBY EXPRESSLY DISCLAIMS ALL LIABILITY FOR ANY SICKNESS, DISEASE, ESTRAY, THEFT, INJURY OR DEATH, WHICH MAY BE SUFFERED BY HORSE DURING THE TIME HORSE IS IN THE CUSTODY OR CONTROL OF ZERLOTTI EQUINE AND CLIENT HEREBY EXPRESSLY WAIVES ALL CLAIMS AND CAUSES OF ACTION WHETHER SOUNDING IN CONTRACT OR TORT, INCLUDING BREACH OF CONTRACT, NEGLIGENCE AND GROSS NEGLIGENCE, AGAINST ZERLOTTI EQUINE, ITS OWNERS, PARTNERS, PRINCIPALS, AGENTS, EMPLOYEES, SERVANTS, VETERINARIANS AND FARRIERS, OR ANY OF THEM, FOR INJURY TO OR DEATH OF HORSE AND ANY PERSONAL INJURY OR LIABILITY WHICH CLIENT, ITS AGENTS OR EMPLOYEES OR ANY THIRD PARTY MAY RECEIVE WHILE ON ZERLOTTI EQUINE'S PREMISES, WHETHER PREMISES ARE OWNED OR LEASED, ARISING OUT OF OR IN ANY WAY CONNECTED WITH BOARDING, CONDITIONING, TRAINING, TREATING, FEEDING, BREEDING, RACING, TRANSPORTING, SHOWING, MARKETING, OR PROVIDING VETERINARIAN CARE OR ANY OTHER SERVICES FOR CLIENT INVOLVING HORSE. CLIENT FULLY UNDERSTANDS AND AGREES THAT ZERLOTTI EQUINE HAS NO OBLIGATION TO PROVIDE FOR CLIENT'S BENEFIT ANY PUBLIC LIABILITY, ACCIDENTAL INJURY, THEFT, EQUINE MORTALITY, CARE, CUSTODY OR CONTROL INSURANCE ON HORSE, AND THAT ALL RISKS CONNECTED WITH THE BOARDING, CONDITIONING, TRAINING, BREEDING, RACING, TRANSPORTATION, SHOWING, MARKETING OR PROVIDING OF ANY OTHER SERVICES TO HORSE ARE TO BE BORNE SOLELY BY CLIENT. ALL IMPLIED WARRANTIES, INCLUDING WARRANTIES FOR MERCHANTABILITY, BREEDING, SHOWING AND FOR FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY EXPRESSLY WAIVED BY CLIENT AND CLIENT HEREBY AGREES THAT ZERLOTTI EQUINE, ITS OWNERS, PARTNERS, PRINCIPALS, EMPLOYEES, AGENTS, SERVANTS, VETERINARIANS, ATTORNEYS, ACCOUNTANTS, FARRIERS, SUCCESSORS AND ASSIGNS OR ANY OF THEM, SHALL NOT BE LIABLE FOR ANY SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES ARISING FROM THE TRANSACTION COVERED BY THIS AGREEMENT, INCLUDING WITHOUT LIMITATION, ANY DAMAGES ARISING FROM THE NON-PERFORMANCE OF OBLIGATIONS WHICH CLIENT MAY HAVE UNDERTAKEN TO ANY THIRD PARTY IN RELIANCE UPON ZERLOTTI EQUINE PROMISES AND REPRESENTATIONS IN THIS AGREEMENT. IN NO EVENT SHALL CLIENT'S REMEDY FOR ANY LIABILITY OR CAUSE OF ACTION ARISING UNDER THIS AGREEMENT EXCEED THE AMOUNT OF THE FEES PAID BY CLIENT UNDER THIS AGREEMENT. WARNING, UNDER TEXAS LAW (CHAPTER 87, CIVIL PRACTICE AND REMEDIES CODE), AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.

14. INDEMNIFICATION AND HOLD HARMLESS OF ZERLOTTI EQUINE BY CLIENT. With the exception that the following provisions of the Section shall in no event be construed to require indemnification by Client in excess of that permitted under the public policy of the applicable law, Client shall indemnify, defend and save harmless Zerlotti Equine, its owners, partners, principals, employees, agents, servants, veterinarians, attorneys, accountants, farriers, successors, assigns, and any of them, of and from: (a) any and all claims, demands, causes of action, damages, costs, expenses, losses or liabilities, in law or in equity, of every kind and nature whatsoever, known or unknown, arising out of or in any manner connected with any damage or injury to a third person or persons or to the property of any third person or persons caused by Horse while it is in the care of Zerlotti Equine, its employees, agents, servants, veterinarians, attorneys, accountants, farriers, successors, assigns, and any of them; and (b) any and all claims, demands, causes of action, damages, costs, expenses, losses, or liabilities, in law or in equity, of every kind and nature whatsoever, known or unknown, arising out of or in any manner connected with Horse which is caused or alleged to be caused by the acts or omissions of Zerlotti Equine, its employees, agents, veterinarians, attorneys, accountants, farriers, successors, assigns, and any of them.

15. At Client's own cost, expense and risk, Client shall defend any and all suits, arbitrations or other proceedings that may be brought or instituted by third persons or by the legal owner of Horse (where Client is not the legal owner) against Zerlotti Equine, its owners, partners, principals, employees, agents, servants, veterinarians, attorneys, accountants, farriers, successors, assigns, or any of them, for any and all in enforcing the indemnity granted in this Section. Zerlotti Equine, its employees, agents, veterinarians, attorneys, accountants, farriers, successors, assigns, or any of them, shall have the right to select its own counsel to defend any claim within the scope of this Section.

16. **WAIVER, AMENDMENT OR MODIFICATION.** No provisions of this Agreement shall be deemed waived, amended or modified by either party unless such waiver, amendment or modification is in writing and signed by the party against whom the enforcement of such waiver, amendment or modification is sought. The failure of Zerlotti Equine to enforce any of the provisions of this Agreement shall not be construed as a waiver of such provision or of the right of Zerlotti Equine thereafter to enforce such provision.
17. **NOTICE:** In the event any notice is to be given under the terms of this Agreement, or if any party hereto desires to give notice to any party to this Agreement, such notice shall be in writing, and may be personally delivered or sent by certified mail, return receipt requested, to the addresses shown above. If such notice is delivered personally, it shall be effective upon such delivery; if mailed, it shall be deemed delivered and effective upon deposit with the United States Post Office.
18. **ACKNOWLEDGEMENT AND CONSENT TO PAYMENT OF COMMISSION.** Client hereby acknowledges and consents to the payment by Zerlotti Equine of a commission to other persons or agents for his/her/its services as Zerlotti Equine's agent in obtaining the purchase of Horse or any breeding provided herein.
19. **ENTIRE AGREEMENT.** The terms of this Agreement are intended by the parties as a final expression of their agreement with respect to such terms as are included in this Agreement and may not be contradicted by evidence of any prior or contemporaneous agreement. No Agreement shall be deemed to exist or to bind any of the parties hereto unless such representation, warranty, condition, understanding or agreement shall be reduced to writing and mutually agreed to by the parties hereto and expressly incorporated herein.
20. **SEVERABILITY.** All provisions of this Agreement prohibited by the law of any applicable jurisdiction shall, as to said jurisdiction, be ineffective to the extent of such prohibition without hereby invalidating any other provisions of this Agreement.
21. **ATTORNEY'S FEES.** In the event that any legal action is brought or instituted by the parties hereto, for any purpose under or in connection with this Agreement, the prevailing party shall be entitled to receive from the losing party all costs of suit, including reasonable attorney's fees. In the event that Zerlotti Equine engages the services of any attorney to enforce any provision of this Agreement, and Zerlotti Equine is successful in so enforcing this Agreement, Client shall pay to Zerlotti Equine the reasonable attorney's fees and expenses incurred by Zerlotti Equine by reason of such enforcement, whether or not legal action is brought.
22. **GOVERNING LAW, JURISDICTION AND VENUE.** This Agreement shall be governed by and be construed in accordance with the laws of the state of Texas. The parties agree that in the event any legal action or other legal proceeding is instituted that arises out of or is in any manner connected with this Agreement, the parties hereby submit to the exclusive jurisdiction and venue of the District Court of Bexar County, Texas.
23. **SUCCESSORS AND ASSIGNS.** This Agreement shall in all respects bind and inure to the heirs, executors, administrators, successors and assigns of the parties. Client, however, shall not have the right to assign any rights or delegate any duties under this Agreement without prior written consent of Zerlotti Equine
