TRANSPORTED FROZEN SEMEN AGREEMENT

THIS AGREEMENT, effective _____, is entered into by and between Zerlotti Equine Reproduction, Ltd. and (hereinafter "Client"): _____ Phone Number: _____

Whereas, the Registered Stallion _____, **Registration #** _____ is standing or has frozen semen stored at Zerlotti Equine Reproduction, Ltd. for the 2010 breeding season which terminates on July 31, 2010. The Client is owner or lessee of the following mare (hereinafter "Mare"):

Whereas, Client has purchased a 2010 breeding for the Mare to _____ and desires to have live, frozen semen shipped to Client using the dry shipper method to satisfy said breeding right. NOW, THEREFORE, THE PARTIES HEREBY AGREE that Zerlotti Equine Reproduction, Ltd. will have the semen shipped from Zerlotti Equine Reproduction, Ltd. to Client for the Mare on the following terms and conditions:

1. Stallion Breeding Contract fee or Re-handling fee must be paid in advance.
2. **A \$500.00 FLAT RATE PER SHIPMENT INCLUDES CONTAINER RENTAL, HANDLING FEE AND PRIORITY OVERNIGHT SERVICE WITHIN THE UNITED STATES.** The fee does not include refundable dry shipper container deposit. A shipping container deposit of \$1,000.00 is required to be held on a credit card and will be refunded upon return of the container. Zerlotti Equine Reproduction, Ltd. reserves the right to ship semen at their sole discretion. Priority Overnight Federal Express shipping fees are charged every time semen is shipped. Additional charges apply for Same Day Federal Express shipping (not recommended) and counter-to-counter shipping. Counter-to-counter shipments may not be available and are dependent upon flight schedules of contracted air carriers.
3. The shipment of semen to the Client will be done by Zerlotti Equine Reproduction, Ltd.
4. Refundable Dry Shipper Container Deposit of \$1,000.00 must be paid to Zerlotti Equine Reproduction, Ltd. **before** shipment will be sent. Deposit will be refunded when the dry shipper is received in good condition by Zerlotti Equine Reproduction, Ltd.
5. Return shipment fee of the shipping container is the responsibility of the mare owner. The Client must return the dry shipper by overnight service to arrive at Zerlotti Equine Reproduction, Ltd. no later than 3 days after Client's receipt. **Client shall pay a \$25.00 per day charge if the shipping container is not received within that time period and subsequent shipments of semen will not be made until the container is returned.** If dry shipper has not been returned within a 2-week period Client will be charged \$1,000.00.
6. THE CLIENT SHALL NOTIFY ZERLOTTI EQUINE REPRODUCTION, LTD. WITH A MINIMUM OF 48 HOURS PRIOR TO SHIPMENT OF SEMEN. **ORDERS MUST BE PLACED BY 10:00 A.M. CST ONE DAY BEFORE SHIPMENT.**
7. Priority in semen transport will be given to those who book earliest and who give 48 hours advance notice (before 10:00 A.M. CST two days before semen is scheduled to be shipped).

11. **Breeding Season is from February 1, 2010 until July 31, 2010.**
